Ideas for a fencing ordinance were brought up by the Zoning Administrator, Linda Kresnak. Discussion by planning commission on height of fence, set back from property lines, maintenance of both sides of the fence, sight lines, who maintains grass by the fence for adjacent property owners, property line offset agreed upon by neighbors (neighbors to sign an agreement) waiver to be signed on the permit.
